**POSITION SUMMARY**: New Jersey Future is seeking an experienced, entrepreneurial and mission-driven planning professional who is ready to help New Jersey communities become more sustainable, equitable, resilient and competitive. The Director will work collaboratively to oversee the growth and development of the Local Assistance program area, identify new and complimentary opportunities, serve as an educator and advocate, and engage in direct service provision. Current planning activities include, community engagement around transformational projects, helping communities access funding for mission-aligned priorities, planning for downtown economic development and equitable revitalization, creating age-friendly communities, and planning for climate change and coastal resilience. The Director will have opportunities to analyze and influence land use policies that impact communities and the state in general. This is a full-time position working within a highly supportive and flexible work environment. The Director reports to the Executive Director, has supervisory responsibilities, works with a co-director and peer directors, oversees and partners with consultants, and will work with other program and policy staff.

## RESPONSIBILITIES

- <u>Program development and administration</u>. Work with a co-director to oversee all local assistance planning program initiatives, including staff. Identify and pursue opportunities to expand existing programs, including ensuring adequate revenue is in place. Increase the number of communities that New Jersey Future works with.
- <u>Project management and implementation</u>. Provide municipal land use planning expertise on all projects, including evaluating local plans, codes and ordinances. Oversee some individual projects, including managing budgets and work plans and carrying out the day-to-day work. Assist with and support the implementation of projects as necessary, including conducting research, convening stakeholders, establishing committees, attending meetings, developing recommendations and writing reports.
- <u>Policy education and advocacy.</u> Convene and attend meetings to educate stakeholders and expand the organization's knowledge base. Make presentations to affiliated organizations, community groups, and elected and appointed officials at all levels. Engage the state's network of planners. Review planning and land-use policy issues aligned with New Jersey Future's priorities as they arise.

**COMPENSATION**: The salary for this full-time position is in the range of \$75,000 - \$95,000 and depends on the candidate's experience and skills. Salary is negotiable. The Director is eligible for annual performance bonuses which are determined at the discretion of the Executive Director.
